## COLLEAGUES

Our team has been specially selected for their professional qualifications, their years of experience and their genuine love of children. Our team aim to provide a healthy, happy environment where your child has the opportunity to reach his or her full potential. All colleagues have passed the Garda vetting process in Ireland and the Enhanced DBS process in the UK.

In Ireland, our colleagues working in an early years' service hold a minimum qualification of at least QQI Level 5 with many holding a 3rd level qualification in Early Childhood Education. There is no regulatory requirement regarding qualifications for colleagues working with school-aged children however many of our colleagues working with this age group are also qualified. Our colleagues in Elephant Park hold a minimum of a Level 2 childcare qualification.

## RATIOS

At a minimum we adhere to the following ratios and often utilise additional educators.

## GENERAL INFORMATION

### What to Bring

Parents are asked to provide the following for their child. Please clearly label all items.

#### All Services

- Tigers is a nut-free zone. Parents are required to ensure that nuts and food containing nuts are not provided.
- Having fun can be messy! Please ensure you pack a spare change of clothes, including underwear, socks and shoes each day. Pack comfortable, clothes that can be layered to allow for changeable weather conditions.
- Children should wear safe footwear such as trainers.
- Sun cream and a sun hat.
- Please have all clothing, equipment, and backpack labelled with your child's name.

#### Early Years Services

- Nappies, wipes and barrier creams (where needed) must be provided for children who require them. Please do not supply pull-ups unless your child is in the process of being toilet trained.
- Prepared bottles must be provided for children who are being bottle-fed. Please refer to our Food, Nutrition & Health Promotion Policy for further information.
- For children attending ECCE hours and in some cases for children attending full day, parents are asked to provide one snack per day, please check with the service manager to confirm what is required for your child. Popcorn is not permitted to be brought in from home. Parents are required to cut grapes, olives and cherry tomatoes in half.
- Parents of children who attend our full day care services are asked to provide toothbrushes & toothpaste for their children.
- There's no such thing as bad weather, just bad clothing and as such we ask that you provide suitable outdoor clothing such as rain/puddle suit and wellies that can be kept at the centre for your child.

#### Sessional Pre-School Services

- One snack per day, please check with the service manager to confirm what is required for your child. Popcorn is not permitted to be brought in from home. Parents are required to cut grapes, olives and cherry tomatoes in half.
- There's no such thing as bad weather, just bad clothing and as such we ask that you provide suitable outdoor clothing each day.



## Toys from Home

It is not permitted for children to bring toys, equipment or technology devices to Tigers Childcare as they may be lost or damaged. All the toys we use are age appropriate and in line with our insurance policy. Tigers do not accept responsibility for any toys, equipment or technology devices that are damaged/lost on the premises.

When a young child is settling in use of a transition object to help with the process is permitted with a view to phasing it out. Children who use a comfort item for going to sleep is permitted. It is the responsibility of parents to ensure that the comfort item is returned daily.

## Mobile Phones

The use of mobile phones by children attending Tigers is prohibited. Should any child wish to contact their parents they may use the phone at Tigers. Likewise, should any parent wish to contact their child they may do so via the Tigers phone.

## Jewellery


Jewellery is not permitted to be worn by children in our early years or pre-school services. This is to safeguard against the risk of choking or skin injuries from getting caught that is posed. This includes amber beads.

## Arranging Meetings

Our childcare centres are busy places and our priority is ensuring the welfare and safety of the children and colleagues at each service. This extends to ensuring staff:child ratios as maintained. If you want to arrange a meeting with a centre manager, please call or email in advance to arrange a suitable time and date.

## PARTNERSHIP WITH PARENTS

We recognise that parents play a fundamental role in a child's development as their first educators and our aim is to always support their role. We welcome parents by operating an open-door policy and involving you in your child's education and care at Tigers Childcare. We encourage parents to share their family individual interests and circumstances with us so that we really get to know you and your child. All information will be treated in a sensitive, respectful and confidential manner. We will communicate with you daily at arrival and collection and add extra detail about food, sleep and nappies on Child Paths. We use forms on Child Paths to record any accidents, incidents and medication details.

## CHILD WELFARE & PROTECTION

Children's First Act 2015 places a legal obligation on certain people to report child protection concerns at, or above a defined threshold, to Tusla – Child and Family Agency. These people are known as 'mandated persons'. Mandated persons must inform Tusla when they have reasonable grounds for concern that a child has been, is being, or is at risk of being abused or neglected. Our colleagues are deemed to be Mandated Persons due to the nature of their work and therefore have a legal responsibility to report child welfare and protection concerns.
